# **PDI Warranty Policy**

All PDI products carry a limited warranty to cover products materials and workmanship for a limited time period. Under specific circumstances such as product modification, incorrect application, installed on racing vehicles or misused and damaged in accidents, these issues can void the product warranty. For specific warranty details, please contact your local dealer or distributor.

## **Demon HD Axles**

Demon HD Axles (excluding boots & clamps) are warrantied to the original purchaser for a 1-year period from the date of purchase. DEMON POWERSPORTS warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation, or alteration. Demon Powersports will send a replacement one time only at Demon Powersports' discretion within 75 days of the purchase date. If it's over 75 days from date of purchase but within the 1-year period there will be a US \$50 replacement fee + shipping fee. For all warranty cases, the purchaser must provide a copy of the invoice and proof of breakage.

## **Demon HD Lift-Kit Axles**

Demon HD Lift-Kit Axles (excluding boots & clamps) are warrantied to the original purchaser for a period of 1 year from the date of purchase. Demon Powersports warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation or alteration. Demon Powersports will ship a replacement one time only at Demon Powersports' discretion within 75 days of date of purchase. If it's over 75 days from date of purchase but within the 1-year period there will be a US \$50 replacement fee + shipping fee. For all warranty cases, the purchaser must provide proof of purchase and proof of breakage.

## **Demon XHD Axles**

Demon X-Treme Axles (excluding boots & clamps) are warrantied to the original purchaser for a period of 2 years from date of purchase. DEMON POWERSPORTS warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation or alteration. Within 1 year from date of purchase, Demon Powersports will ship a replacement one time only at Demon Powersports' discretion. If the axle fails after 1 year but within 2 years from the date of purchase, the purchaser must pay a fee of US \$100 for a replacement axle + shipping fee. The warranty can be claimed one time only. The customer must provide all information as requested by Demon Powersports.

## **Demon XHD Long Travel Axles**

Demon X-Treme Long Travel Axles are warrantied to the original purchaser for a period of 2 years from date of purchase DEMON POWERSPORTS warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation or alteration. Within 180 days from date of purchase, Demon Powersports will ship a replacement one time only at Demon Powersports' discretion. If the axle fails after 180 days, but within the 2 years from the date of purchase, the purchaser must pay a flat fee of US \$100 for a replacement axle + shipping fee. The warranty can be claimed one time only. The customer must provide all information as requested by Demon Powersports.

## **Demon - Heavy Duty Ball Joint**

Demon Powersports warrants its Demon Ball Joint to the original purchaser for 1 year from the date of purchase against manufacturing defects in workmanship and material only. Demon Powersports warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation or alteration.

## **Demon – Sintered Brake Pads**

Demon Powersports warrants its Demon Brake Pad to the original purchaser for 1 year from the date of purchase against manufacturing defects in workmanship only. Demon Powersports warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation, alteration or wear and tear.

#### **Demon - RZR 170 Axle**

Demon RZR170 Axles (excluding boots & clamps) are warrantied to the original purchaser for a period of (1) year from the date of purchase. Demon Powersports warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation or alteration. Demon Powersports will ship a replacement one time only at Demon Powersports' discretion within (75) days of the date of purchase. If it's over (75) days from date of purchase but within the (1) year period there will be a US \$75.00 replacement fee + shipping fee. In all warranty cases, the purchaser must provide proof of purchase and proof of breakage.

## Rugged - Windshield

Demon Powersports warrants its Demon Windshields to the original purchaser for (1) year from the date of purchase against manufacturing defects in workmanship only. Demon Powersports must be contacted immediately in case of the defective product received and not attempt to install or use the product. Demon Powersports warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation or alteration. In all warranty cases, the purchaser must provide proof of purchase and proof of breakage.

## Rugged - Performance Axles

Rugged Performance Axles (excluding boots & clamps) are warrantied to the original purchaser for a period of (1) year from the date of purchase against manufacturing defect only. Demon Powersports must be contacted immediately in case of the defective product received and not attempt to install or use the product. Demon Powersports warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation or alteration. Tearing a boot is not covered unless it can be shown there was a manufacturing defect. In all cases purchaser must provide proof of purchase and proof there was a defect

# Rugged - Propeller Shaft

Rugged ATV/UTV Parts warrants its propeller shaft Joint to the original purchaser for 1 year from the date of purchase against manufacturing defects in workmanship and material only. Rugged ATV/UTV Parts warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation or alteration.

# Rugged – Electric Power Steering Kit

Rugged ATV/UTV Parts warrants its Power steering kit to the original purchaser for 1 year from the date of purchase against manufacturing defects in workmanship and material only. Rugged ATV/UTV Parts warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation or alteration. If it's over six months from date of purchase but within the 1-year period there may be a replacement fee subject to the part.
